

Pursuant to Section 18004(e) of the CARES Act each Higher Education Emergency Relief Fund participating institutions must post certain information on the institution's primary website. This is the final posting as all funds made available to students have been distributed to students. In accordance with Section 18004(e) of the CARES Act New England Institute of Technology (NEIT) posts the following information:

- 1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
 - NEIT's Response: In accordance with the CARES Act New England Institute of Technology signed and returned to the Department of Education the Certification and Agreement that the institution will us no less than 50% of the funds received under the CARES Act to provide Emergency Financial Aid Grants to students.
- 2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.
 - NEIT's Response: The institution was awarded \$1,838,021 to be distributed to students under the Emergency Financial Aid Grant to Students.
- 3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter).
 - NEIT's Response: As of December 31, 2020, \$1,838,021 of funds have been distributed to students under Section 18004(a)(1) of the CARES Act.
- 4. The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.
 - NEIT's Response: There are approximately 1,625 NEIT students enrolled in the Spring 2020 eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants under Section 18004(a)(1) of the CARES Act.
- 5. The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.

NEIT's Response: 1,025 students have received Emergency Financial Aid Grants as of December 31, 2020.

- 6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.
 - NEIT's Response: The institution sent a survey to all students who could qualify for the grant. The survey asked the student if they have incurred any costs related to NEIT changing its delivery of courses due to the coronavirus, in the following areas: technology, food, housing, course materials, health care or childcare. If the student attested to incurring such costs, NEIT qualified this student for the grant. All grants will be issued in equal amounts for students who qualified for the grant:
- 7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants
 - NEIT's Response: NEIT has e-mailed formal instructions on a letter describing the Emergency Financial Aid Grant to all eligible students with information on how to contact Financial Aid should they have any specific questions.
